Release of Liability and Indemnity Agreement

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS **PLEASE READ CAREFULLY BEFORE YOU SIGN**

The undersigned **Parent or Legal Guardian, on behalf of the Minor named below** understands and agrees as follows:

1. The undersigned is an unpaid volunteer for the Jacksonville Aviation Authority, and is willingly participating in this activity.
2. The Jacksonville Aviation Authority assumes no responsibility for the actions or omissions, personal safety or property of volunteers while traveling to or from, or while at Jacksonville Aviation Authority locations while performing duties as a volunteer and disclaims responsibilities for all liabilities, claims or damages which might arise in connection therewith.
3. The undersigned assumes all risk, and agrees that he/she is solely responsible for his/her own actions, omissions and health, safety and welfare while traveling to, from or at Jacksonville Aviation Authority locations while performing duties as a volunteer.
4. The undersigned hereby releases the Jacksonville Aviation Authority from any and all liabilities, claims, damages or actions, whatsoever and howsoever arising, out of or in connection with his/her travel to or from or while performing duties as a volunteer.
5. The undersigned agrees to indemnify, defend and hold the Jacksonville Aviation Authority harmless from and against any and all claims, liabilities and expenses incurred by any or each of them, as a result of or in any way arising with respect to his/her travel to or from, or while performing duties as a volunteer, including but not limited to any and all claims for personal injury or property damage sustained, and attorney's fees and costs incurred by the undersigned.
6. The undersigned agrees to abide by all JAA Rules and Regulations covering the use and/or access to JAA properties including; the Jacksonville International Airport (JIA), Jaxex Airport, Herlong Airport and Cecil Airport as may be promulgated by the Authority in the interests of health, safety, sanitation and good order.

7. The undersigned agrees to grant the Jacksonville Aviation Authority, its respective licenses, successors and assigns the right to perpetually use, publish and copyright his/her name, voice, picture, portrait, likeness, occupation and testimonial in all media for the Jacksonville Aviation Authority.

8. The undersigned understands that there will be no monetary distribution for his/her participation in any advertising or promotion.

9. The undersigned understands that nothing herein obligates the Jacksonville Aviation Authority, its respective licenses, successors and assigns to use his/her name, voice, picture, portrait, likeness, occupation and testimonial in any advertising or promotion.

10. The undersigned releases obligates the Jacksonville Aviation Authority, its respective licenses, successors and assigns from any liability or damages resulting from the use of his/her name, voice, picture, portrait, likeness, occupation and testimonial in the manner described within.

This Release of Liability and Indemnity Agreement shall be governed by the laws of the State of Florida, and any legal action relating to or arising out of this Waiver and Permission Form shall be commenced exclusively in the Circuit Court of the Fourth Judicial Circuit in and for Duval County, Florida (or if such Circuit Court shall not have jurisdiction over the subject matter thereof, then to such other court sitting in such county and having subject matter jurisdiction), **AND I SPECIFICALLY WAIVE THE RIGHT TO TRIAL BY JURY.**
