



# Release and Waiver of Liability Assumption of Risk and Indemnity Agreement

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS  
PLEASE READ CAREFULLY BEFORE SIGNING

IN CONSIDERATION of being permitted to volunteer and participate in the **Jacksonville Aviation Authority's (JAA) Triennial Exercise** ("Event") and enter certain RESTRICTED AREAS, defined as any area on JAA's property including but not limited to those areas requiring special authorization, credentials, or permission to enter and not open to the general public, the UNDERSIGNED, on his/her behalf and for his/her personal representatives, heirs and next of kin, and/or as **Parent or Legal Guardian for the Minor child named below**, understands and agrees as follows:

1. He/She has inspected or, immediately upon entering onto JAA's property and/or any of its RESTRICTED AREAS (collectively the RESTRICTED AREAS), will continuously inspect the RESTRICTED AREAS which he/she enters, and he/she further agrees and warrants that, if at any time, he/she is in or about RESTRICTED AREAS and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate or cease participating further in the EVENT. He/She further acknowledges that he/she may not have the opportunity to inspect any RESTRICTED AREAS prior to the Event and assumes any risks associated with the same.

2. He/She HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE JAA, its representatives, contractors, consultants, volunteers, participants, administrative organizations or any affiliated entities thereof, as well as any event personnel, rescue personnel, persons in the RESTRICTED AREAS, advertisers, tenants, inspectors, surveyors and others who give recommendations, directions, or instructions for the Event and for each of their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees," FROM ALL LIABILITY TO THE UNDERSIGNED, HIS/HER PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS AND NEXT OF KIN FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. He/She HEREBY AGREES TO INDEMNIFY, SAVE, DEFEND AND HOLD HARMLESS JAA and the Releasees FROM ANY LOSS, LIABILITY, DAMAGE, OR COST INCLUDING BODILY INJURY OR PROPERTY DAMAGE they may incur arising out of his/her presence or participation in the Event, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

4. He/She recognizes the potential for risk and HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the Event, whether caused by the NEGLIGENCE OF RELEASEES or otherwise.

5. He/She HEREBY acknowledges HIS/HER VOLUNTARY PARTICIPATION in the Event and that THE ACTIVITIES OF THE EVENT MAY INVOLVE CERTAIN INHERENT RISKS and involve the risk of serious injury and/or death and/or property damage. THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED BY OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. He/She HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement EXTENDS TO ALL ACTS OF NEGLIGENCE BY THE RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State of Florida and that, if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I AM AT LEAST 18 YEARS OF AGE AND FULLY COMPETENT AND I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK AND INDEMNITY AND FULLY UNDERSTAND ITS TERMS AND FULLY INTEND TO BE BOUND BY THE SAME; I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE, DURESS, OR GUARANTEES BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
